CONDITIONS OF MEMBERSHIP

CLUB RULES:

- All members undertake to at all times abide by all the rules of Pagham Yacht Club (here after mentioned as the Club), as may be amended from time to time as published on the Club website.

INSURANCE:

- All registered boats, kayaks and windsurfing boards must, whilst at Pagham Yacht Club (here after mentioned as the Club), shall be fully insured for third party cover with a minimum liability of £2,000,000, a valid copy of the insurance certificate for each vessel is to be provided to the membership secretary.
- The Club has full Public Liability Insurance with a minimum liability of £5,000,000

MEMBERS BOATS & EQUIPMENT:

- Any personal equipment stored in the Club Dinghy Park or Container is stored entirely at the owner's risk, the Club cannot be held responsible for any loss or damage that may occur.
- By storing your equipment at the Club, you are agreeing to the Club procedure for identifying boats and equipment and the allocation of spaces.
- This also includes the right of the Club to move or sell abandoned boats, kayaks, boards, trailers or associated equipment.

CLUB BOATS & EQUIPMENT:

- Using any equipment belonging to the Club is done so entirely at the members own risk.

YOUTH(S) / CHILDREN:

- Each child registered as a member of the Club must be done so with their Parents/Guardians' consent.
- Pagham Yacht Club including all member volunteers **DO NOT ACT** as "in loco parentis" or in any other supervisory capacity, and that all Parents/Guardians will be responsible at all times for their registered child's good conduct whilst on Club Premises and/or taking part in Club activities.
- Parents/Guardians also agree not to hold the Club liable for any accident or other difficulty in which any such child may become involved.
- The club has a nominated Child Protection Officer and Child Protection Policy.

PHOTOGRAPHS:

- It is likely that members will be photographed during Club activities and events, including by third parties or press.
- It is club policy that unless a member indicates otherwise on their renewal form these photos will be used as the club sees fit, which may include, displayed on the club walls, publicity documents, Club website or Club Facebook page.
